Value of the Project

Urban growth is projected to add close to 100 million acres of urban land to the United States by 2060. Preserving at-risk parcels near cities delivers critical environmental and social impacts to metro areas. The 185-acre oak-hickory Anneewakee Forest Preserve is situated in the densely populated and growing Atlanta metropolitan area. The 85-year-old forest was zoned residential in a suburban area experiencing rapid residential growth. GALT's protection of this forest ensures green spaces for residents and wildlife in Douglas County. The Preserve will provide easy access to nature for under-resourced communities, enhanced watershed function, and priority habitats. By investing in this project, your company can make a positive impact right in its own backyard.

Unique Public Interest Credits

These carbon credits are public interest credits – a non-profit land trust preserving a forested natural area as a public resource. Through the generation of these credits, improved air quality, reduced stormwater runoff, and reduced heat will result, while also delivering social equity and human health impacts. CFC credits are endorsed by the prestigious International Carbon Reduction and Offset Alliance (ICROA). Buyers can confidently offset their carbon emissions with a public interest credit while giving back to their local communities. Buyers of CFC credits include PayPal, Dominion Energy, Xcel Energy, City of Austin, and more, all seeking the rare community-based credits issued by CFC.
